



By registering for Race to Remember 2025 and choosing to do so via a charity place, you agree to the following terms and conditions:

1. To raise a minimum of **£395** in return for a heavily discounted registration fee.
2. To submit at least **75%** of this target (**£296.25**) 4 weeks prior to the event (by **Friday 10 October 2025**).
3. If you are unable to meet the minimum fundraising target by this date, you will be given the option to switch to a self-funded place where you will be asked to pay the appropriate registration fee difference to retain your event place:

36km early bird	£125 - £45 = <b>£80</b> to pay
36km from 01/01/25	£125 - £55 = <b>£70</b> to pay
76km early bird	£175 - £70 = <b>£105</b> to pay
76km from 01/01/25	£175 - £85 = <b>£90</b> to pay

4. Where you are unable to meet this initial target, and there is no prospect of you meeting the minimum fundraising target, and you don't want to switch to a self-funded place, Combat Stress reserves the right to revoke your place in the event without refunding your registration fee.

For all participants whether own place or charity place, you agree to:

5. Inform the Combat Stress Challenge Team immediately if I am unable to take part in the event. All monies paid to Combat Stress by this time are non-refundable and will be treated as a donation.
6. Endeavour to pay to Combat Stress all offline donations within six weeks of the event date and return all used and un-used sponsorship forms.
7. Not hold on to money raised but send it to Combat Stress regularly in cheque form (made payable to Combat Stress), BACs or paid directly via my online sponsorship page. All online donations will automatically be sent to Combat Stress.
8. Not raise funds by carrying out 'door to door' or unsolicited collections.
9. Not collect in any public place without first obtaining a collector's license from the local authority.
10. Not collect on private property (including shops, pubs etc.) without obtaining the owner's permission.
11. Not conduct any raffle, lottery or public collection without first contacting the Combat Stress Challenge Team.

- 12.** Consent that any photos taken of me at my event may be used on Combat Stress social media pages and marketing materials (please note you can refuse their use at the point of being taken and ask for the photos to be removed from our social media at any time).
- 13.** Fully prepare myself for the physical challenge of the event and not hold Combat Stress responsible or liable in any way for any accident, injury or illness sustained.
- 14.** Not do anything to bring Combat Stress into disrepute.
- 15.** Agree that my data will be shared with Classic Challenge as necessary for the safe delivery of the event, at no time will your information be shared for marketing purposes.
